



RESERVATION CONTRACT for an American Pitbull Terrier's puppy.

With this contract choose the number of choice: ... ^ of a puppy of sex son of (stallion name) and (name mare).
The mount between the two subjects was carried out or will be carried out on

The choice of the puppy will take place between the thirtieth and the fortieth day after birth at the discretion of the breeder. This choice can be made through photos and videos sent by the breeder to the customer via e-mail or mobile phone or personally by going to the breeder's facility in accordance with his availability.

The choice is made independently among all males puppies if a reservation has been made for a male, while among all females puppies if a female has been booked. The priority of choice, understood as the possibility to choose a puppy before another person, is based on the number of choice indicated in the present contract: it means that whoever has a lower number choice will choose before another customer with a higher number, therefore we must wait for the choice of those who have a lower number than their own before being able to make their choice.

The puppy will be delivered as a pet, vaccinated, wormed and microchipped. The pedigree will be delivered according to the timing of the institution related to the release of the pedigree. At the time of sale, the breeder verifies through the execution of a visit and the relative signing of a certificate of good health signed by a veterinarian that the puppy is in good physical health.

The guarantee once left the breeding has a duration of 15 days and only on viral diseases such as: parvovirus and distemper (considered in veterinary medicine the maximum period of incubation for these diseases).

Possible parasites such as: worms, protozoa or coccidia etc. are not taken into consideration in the guarantee as, besides not being dangerous for the puppy if properly treated, they are very common parasites in parks, roads or dog areas that the puppy can take after the adoption with great ease, obviously the breeder will have previously treated the puppy previously for such parasites.

With regard to the refusal of vices, the guarantee is six months from the date of birth of the puppy, and the puppy can be returned, obtaining in exchange, depending on the availability and programming of the mates, another puppy; or it can be maintained by the buyer with a partial refund corresponding to 30% of the value paid. This guarantee is considered valid on the condition that the dog defect is declared to the breeder within a maximum period of six months of age of the dog through certified communication channels such as registered or pec (alberto.alfonso@pec.it).

Any surgery or treatment that will be carried out on the puppy without the breeder's authorization will not be reimbursed, therefore surgical interventions that fall within the competence of guarantee will be carried out eventually and exclusively at the discretion of the veterinarian of the farm and not by professional third parties, otherwise in addition to having no refund, the guarantee will be void. If, on the other hand, the dog should unfortunately die during the operation, if the responsibility for the death was attributed to the breeding, another puppy will be given free of charge, without any reimbursement for autopsy costs or various types of investigations; if at that time there were no

puppies available for transfer, the buyer will be immediately informed as soon as there is a puppy available.

Additional Conditions:

- 1) The Buyer expressly declares that it is not an animal dealer / retailer and that the dog is acquired for himself as a pet dog.
- 2) The Buyer agrees to collect the puppy only after the sixty-first day of life with the possible balance of the agreed amount, but no later than the seventieth day of age, unless otherwise agreed and previously signed with the breeder. Otherwise the deposits paid and the right to withdraw the puppy will be lost. The breeder can also reserve the right to retain the puppy for an indefinite period of time if he considers that the puppy was not ready for the sale.
- 3) The Buyer agrees to keep the dog in excellent health by ensuring periodic routine veterinary checks, checks in the event of illness or illness; regular and periodic vaccination cycles in relation to contagious diseases present in the area of residence, and prophylactic interventions for internal and external parasites.
- 4) The Buyer agrees to provide physical exercises and to socialize the dog with similar and human to maintain an adequate physical form and a correct socialization and character formation and to NEVER hold the dog tied to a chain (even if it were regulated in the state of residence of the dog) or in a place unsuitable for his psycho-physical needs.
- 5) The Buyer agrees to provide the dog with an adequate diet consisting of high quality dry or moist high quality foods.
- 6) The Buyer accepts that the dog lives in his own home, in the family environment, having in this way to develop a balanced character; the place where the dog is held in the absence of the owners must be totally enclosed and free of dangers.
- 7) The Buyer accepts that the dog is not used in any activity or action that could endanger its character, health or life and to inform the competent authorities about any loss, changes of residence and death by showing related documentation.
- 8) The Buyer has the full right to castrate / sterilize the dog unless otherwise indicated on the "Notes" of this contract; if the Buyer decides not to castrate / sterilize the dog, he agrees to pair the dog only and exclusively with dogs of the same requirements (good pedigree, healthy and with pedigree) approved in advance by the Breeder.
- 9) The Buyer agrees to provide the breeder with the Whatsapp smartphone application, email or facebook photos of the dog and to allow the use of such material sent for the promotion of the Breeding and to show the animal personally to the breeder for checks on his condition and on his growth when requested.
- 10) The Breeder declares that both parents are healthy subjects and in excellent health conditions on the date of their ascent.
- 11) The breeder declares that the puppy received the first vaccination.
- 12) The Buyer declares to explicitly sign and accept the renouncement to obtain refunds or credits if the dog for any reason was returned to the transferor breeder.
- 13) The Buyer declares that he intends to allocate the puppy object of this contract only to the following function: companion dog.
- 14) The Buyer declares to carefully view the puppy, which is the object of the same contract, before proceeding to collect it and that it is appreciated for its morphology and character so as not to have reservations in its qualities; the breeder declines all responsibility for aesthetic, morphological or character defects present in the dog after the transfer.
- 15) Upon shipment, the buyer assumes all risks and liabilities concerning the puppy's health. The risks of shipping are therefore completely borne by the buyer.
- 16) If for any reason you decide not to collect the puppy any more, no payment or deposit will be refunded.
- 17) The shipping costs are fully borne by the buyer and must be paid before the journey is booked. The buyer, if he wishes, can choose to collect the puppy from him personally upon notice and agreements made and signed with the breeder.
- 18) If for any reason the number of puppies born was less than the bookings taken or possibly the conception, the pregnancy or the growth of the puppies were not successful for any possible reason the deposits will not be returned but the breeder will provide for guarantee the delivery of a puppy of

equal choice of one of the following litters available based on the availability and programming of the couplings.

19) If the breeder considers that the puppy chosen by the buyer presents health problems, morphological or temperamental, the purchase of the puppy will be moved to one of the successive litters of the same mare or to a different one without any possibility of reimbursement of payments made.

20) If requested: the first deposit is to be paid at the time of booking, the second deposit will be paid strictly upon the choice of the puppy between the thirtieth and the fortieth day from the birth. Both deposits will be lost and therefore not returned unless all the points and agreements made on this contract are respected.

21) The breeder has at any time the right to terminate the contract and decide not to transfer the puppy to the buyer any more provided that he returns to the buyer the payments made up to that point and without interest.
